Preview Period

Preview data will be available to participating inpatient psychiatric facilities via the *Hospital Quality Reporting (HQR) Secure Portal* from **May 6–June 4, 2024**.

Access Preview Data

1. Navigate to the HQR page: <https://hqr.cms.gov/hqrng/login>
2. Enter your Health Care Quality Information Systems Access Roles and Profile User ID and Password. By logging in, you agree to the terms and conditions. Select **Log In**.
3. You will see the **Two-Factor Authorization page**. Select **Text** or **Email**. Then, select **Next**.
4. Enter the code you received and select **Next**.
5. On the **HQR landing** page, hover over the Lock Menu on the left side.
6. Select **Program Reporting**.
7. From the drop-down menu, select **Public Reporting**.
8. The page will refresh, and the data will be available to preview.
