Calendar Year (CY) 2024 Electronic Clinical Quality Measure (eCQM) Submission Overview

Program Requirements	<p>Submit data for three eCQMs selected by CMS and three self-selected eCQMs for all four quarters of CY 2024 data. The eCQMs must be the same eCQMs across quarters in the reporting year. Each quarter must contain the same six eCQMs.</p> <p>3 CMS-selected eCQMs</p> <ol style="list-style-type: none"> 1. Safe Use of Opioids–Concurrent Prescribing 2. Cesarean Birth (Perinatal Care [PC]-02) 3. Technical Requirements	<ul style="list-style-type: none"> • Use the Office of the National Coordinator (ONC) Health Information Technology certification criteria to meet the Certified EHR Technology (CEHRT) requirement. • Use eCQM specifications published in the 2023 eCQM annual update for CY 2024 reporting and applicable addenda, available on the eCQI Resource Center. • Use the 2024 CMS Implementation Guide for Quality Reporting Document Architecture (QRDA) Category I, Schematron, and sample QRDA Category I files on the Eligible Hospital/ Critical Access Hospital eCQMs page of the eCQI Resource Center. 	Successful Submission	<p>Data must be submitted through the <i>HQR Secure Portal</i> as any combination of the following:</p> <ul style="list-style-type: none"> • QRDA Category I files with patients meeting the initial patient population of the applicable measure(s) • Zero denominator declarations • Case threshold exemptions
		File Validation Tool	<p>Via the HQR System, hospitals and their vendors can validate QRDA Category I test and production file structure and contents and generate CSV files for feedback to correct QRDA Category I files prior to production re-submissions.</p>
Who Can Submit Data	<ul style="list-style-type: none"> • Hospitals with a Health Care Quality Information Systems Access Roles and Profile (HARP) account can submit. • Electronic health record vendors can create a HARP account to submit data on the hospital's behalf. <p>Hospitals can log in to the HQR Secure Portal and the Vendor Management System to assign, modify, and remove vendor access from one page.
