   By logging in, you agree to the terms and
   conditions. Select Log In.
- You will see the Two-Factor
   Authorization page. Select Text or Email. Then, select Next.
- 4. Enter the code you received and select **Next**.
- 5. On the HQR system landing page, hover over *Lock Menu* on the left side.
- 6. Select Program Reporting.
- 7. From the drop-down menu, select **Public Reporting.**
- 8. The page will refresh, and the data will be available to preview.
