

Screening for Social Drivers of Health Measure and the Screen Positive Rate for Social Drivers of Health Measure

In the [FY 2024 IPF PPS final rule](#) (pages 51107-51121), CMS includes two new measures that inpatient psychiatric facilities (IPFs) participating in the Inpatient Psychiatric Facility Quality Reporting (IPFQR) Program are required to report on, the Screening for Social Drivers of Health Measure and the Screen Positive Rate for Social Drivers of Health Measure.

Measure Name: Screening for Social Drivers of Health

Description: The Screening for Social Drivers of Health Measure assesses whether an IPF implements screening for all patients that are 18 years or older at time of admission for food insecurity, housing instability, transportation needs, utility difficulties and interpersonal safety. To report on this measure, IPFs will provide: (1) The number of patients admitted to the IPF who are 18 years or older at time of admission and who are screened for each of the five HRSNs: Food insecurity, housing instability, transportation needs, utility difficulties, and interpersonal safety; and (2) the total number of patients who are admitted to the IPF who are 18 years or older on the date they are admitted. Additionally, patients who expire during the IPF stay are excluded.

Measure Numerator: The numerator consists of the number of patients admitted to an IPF stay who are 18 years or older on the date of admission and are screened for all of the following five HRSNs: Food insecurity, housing instability, transportation needs, utility difficulties, and interpersonal safety during their IPF stay.

Measure Denominator: The denominator consists of the number of patients who are admitted to an IPF stay and who are 18 years or older on the date of admission.

Exclusions: The following patients can be excluded from the denominator: (1) Patients who opt- out of screening; and (2) patients who are themselves unable to complete the screening during their IPF stay and have no legal guardian or caregiver able to do so on the patient's behalf during their IPF stay. Additionally, patients who expire during the IPF stay are excluded.

Clarifying Information: The Screening for Social Drivers of Health measure will be calculated as the number of patients admitted to an IPF stay who are 18 years or older on the date of admission screened for all five HRSNs (food insecurity, housing instability, transportation needs, utility difficulties, and interpersonal safety) divided by the total number of patients 18 years or older on the date of admission admitted to the IPF. IPFs would report using their CCN through the Hospital Quality Reporting (HQR) System.

Measure Name: Screen Positive Rate for Social Drivers of Health

Description: The Screen Positive Rate for Social Drivers of Health Measure provides information on the percent of patients admitted for an IPF stay who are 18 years or older on the date of admission, were screened for an HSRN, and who screen positive for one or more of the following five HRSNs: Food insecurity, housing instability, transportation problems, utility difficulties, or interpersonal safety.

Measure Numerator: The numerator consists of the number of patients admitted for an IPF stay who are 18 years or older on the date of admission, who were screened for all five HSRN, and who *screen positive* for having a need in one or more of the following five HRSNs (calculated separately): Food insecurity, housing instability, transportation needs, utility difficulties or interpersonal safety.

Measure Denominator: The denominator consists of the number of patients admitted for an IPF stay who are 18 years or older on the date of admission and are screened for all of the following five HSRN (food insecurity, housing instability, transportation needs, utility difficulties and interpersonal safety) during their IPF stay.

Exclusions: The following patients can be excluded from the denominator: 1) Patients who opt- out of screening; and 2) patients who are themselves unable to complete the screening during their IPF stay and have no caregiver able to do so on the patient’s behalf during their IPF stay.

Clarifying Information: The result of this measure would be calculated as *five separate rates*. Each rate is derived from the number of patients admitted for an IPF stay and who are 18 years or older on the date of admission, screened for an HSRN, and who screen positive for each of the five HRSNs—food insecurity, housing instability, transportation needs, utility difficulties, or interpersonal safety—divided by the total number of patients 18 years or older on the date of admission screened for all five HRSNs.
