Overall Star Ratings Background

Project Overview and History

Objective:

Develop a methodology to summarize measure information on Care Compare in a way that is useful and easy to interpret for patients/caregivers.

History:

- 2015 Star Ratings Dry Run (v1.0)
- 2016 Star Rating officially launched (v2.0)
- 2017 Star Ratings methods updated (v3.0)
- 2021 Star Ratings methods updated (v4.1)
- 2022 First Star Ratings refresh impacted by CMS COVID-19 exception (v4.1)

Guiding Principles


Use methods that:

- Are scientifically valid.
- Are inclusive of hospitals and measure information.
- Account for heterogeneity of available measures and hospital reporting.
- Accommodate changes in the underlying measures.

Aim to fulfill:

- Alignment with Care Compare and other CMS programs.
- Transparency of methods.
- Responsiveness to stakeholder input.


Historical Timeline

Current Overall Star Rating Methodology



2023 Star Ratings Methodology Highlights

- Same methodology as 2021 and 2022 Star Ratings, which was vetted and approved in rulemaking.
- Veterans Health Administration (VHA) hospitals are now eligible to receive Star Ratings.
- 1 Timely + Effective Care measure <u>retired</u>:
 - OP-33 (retired January 2022)
- 1 Timely + Effective Care measure added:
 - o HCP COVID-19

2023 Star Ratings

Differences Between 2022 and 2023 Star Ratings

Same in 2023

- Overall methodology (v4.1)
- All measure groups still contain many measures without major retirement.

Different in 2023

- CMS has reevaluated and respecified individual measures if necessary due to COVID-19.
- Greater data availability compared to 2022, given the Extraordinary Circumstance Exception (ECE).
- Veterans Health Administration (VHA)
 hospitals now eligible to receive Overall
 Star Rating.

ECE Impact


 The percentage of included data-months in each measure group that was collected after June 30, 2020 (the ECE period was January 1, 2020 – June 30, 2020):

 68% of all data-months included in 2023 Star Ratings were collected after June 30, 2020.

Star Ratings in the COVID World

 As of January 2023 Care Compare data, most Star Rating measures have data periods entirely post-June 2020.

 July 2023 release may represent a "new normal" for Star Ratings.

Number of Hospitals with a Star Rating

2022 Star Ratings: **3,122 Hospitals**

2023 Star Ratings: **3076 Hospitals**

- Compared to 2022 Star Ratings, a net of just 46 fewer hospitals receive a Star Rating using January 2023 data:
 - 236 hospitals no longer meet criteria to have a Star Rating
 - 27 hospitals no longer included in dataset
 - 209 hospitals have data but no longer meet Star Rating criteria
 - 190 hospitals newly meet criteria for Star Rating

Number of Hospitals with a Star Rating by Peer Group

 Compared to 2022 Star Ratings, slightly fewer hospitals in the 3- and 4-group peer groups have a 2023 Star Rating.

Overall Star Ratings Distribution

 Distributions of Star Ratings across all hospitals are very similar across 2022 and 2023 Star Ratings.

Star Ratings Distributions by Peer Group

 Distributions of Star Ratings across peer groups are quite similar across 2022 and 2023 Star Ratings, especially for 2- and 3-star hospitals.

Why did hospitals drop out of 2023 Star Ratings?


- 209 hospitals with January 2023 data do not get a Star Rating but did have a 2022 Star Rating.
- These hospitals were less likely to report at least 3 mortality measures or HCAHPS measures.

Largest Drops for COPD Mortality, HF Mortality, and HCAHPS

- Most hospitals with 2022 Star Ratings but no 2023 Star Ratings only had 3 mortality measures in 2022.
- Drop in reporting for COPD Mortality likely causing most of these hospitals to drop out of Star Ratings.



Shifts in Peer Grouping between 2022 and 2023 Star Ratings

- Most hospitals, 2647 (86%) remain in the same peer group in 2023 as 2022.
- Peer Group 3 most affected: of 227 hospitals in group in 2022, only 79 (34.8%) remain in 2023.
- Peer Group 4 also affected: of 490 hospitals, 280 (57%) remain in group in 2023.

Summary

- Only 46 net fewer hospitals will receive an Overall Star Rating in 2023 than in 2022, which is a smaller decrease than seen between previous year-to-year Star Rating refreshes.
- The decrease in COPD cohort size is the main reason for hospitals dropping out of Star Ratings and shifts in peer grouping.
- We anticipate that results reflect a new baseline for Star Ratings moving forward given the ongoing impact of COVID-19.

Clarifications About Star Ratings

Clarification #1

Why are Star Ratings not released the same month each year?

The Timing of Star Ratings

 CMS has selected refresh criteria within the bounds of rulemaking that maximize available information consistent with principles.

 Compared to 2022 Star Ratings, the number of hospitals with a Star Rating across peer groups is more similar for January 2023 than July 2022 data would have been, primarily due to suppression of PN and PSI measures for July 2022 data.

Clarification #2

Why are Star Ratings peer grouped based on the number of measure groups rather than any other hospital characteristics?

Peer Grouping

- Peer grouping was introduced to the Star Ratings methodology in 2021 with the goal of making like-to-like comparisons among hospitals in the program.
 - Peer measure groups correspond to hospital differences (e.g., size, volume, case and service mixes).
- Hospitals by peer measure group:
 - 3 measure peer group 194 (6.3%)
 - 4 measure peer group 462 (15.0%)
 - 5 measure peer group 2,420 (78.7%)

Peer Grouping

- Compared to the 5-measure peer group, fewer hospitals in the 4-measure peer group have at least 3 measures in either Mortality or Safety of Care.
- Compared to the 4-measure peer group, fewer hospitals in the 3-measure peer group have at least 3 measures in either Readmission or Timely & Effective Care.

Peer Grouping

 Hospitals in the 5-measure peer group are more likely to be larger teaching hospitals, DSH payment eligible, non-CAH's and non-safety net compared to hospitals in the 3-measure and 4-measure peer groups.

Clarification #3

Do Hospitals influence Star Ratings by choosing which measures to report?

Public Reporting

- Hospitals participating in CMS programs are required to collect data for measures reported on Care Compare.
- Each underlying measure has established thresholds (such as minimum case count) for a hospital's score to be publicly reported to ensure reliable measurement.
- If a hospital does not meet threshold for a measure, its score is not reported publicly and does not factor into Star Ratings.
- However, in general, hospitals do <u>not</u> have a choice in measures for which their data is collected.

2023 Implementation

- Hospital-Specific Reports scheduled to be available on 5/2.
- Preview period is scheduled for 5/3-6/1.
- 2023 Star Ratings go live scheduled for 7/26.
