Purpose

This presentation will summarize updates to the IPFQR Program as outlined in the fiscal year (FY) 2025 Inpatient Psychiatric Facility Prospective Payment System (IPF PPS) final rule.

Finalized Updates

FY 2025 IPF PPS Final Rule

- The FY 2025 IPF PPS final rule was published on August 7, 2024, in the Federal Register:

IPFQR Final Rule Summary

- Adopted one new measure: 30-Day Risk-Standardized All-Cause Emergency Department Visit Following an IPF Discharge (IPF ED Visit measure) beginning with the CY 2025 reporting period/FY 2027 payment determination.
- Did not finalize the proposal to require IPFs to submit data on a quarterly basis for patient-level measures.
- Summarized comments on the RFI regarding the IPF Patient Assessment Instrument (IPF-PAI).

Adoption of IPF ED Visit Measure

- Finalized adoption of 30-Day Risk-Standardized All-Cause Emergency Department Visit Following an IPF Discharge (IPF ED Visit) measure.
 - Complements the Thirty-Day All-Cause Unplanned Readmission Following Psychiatric Hospitalization in an IPF measure.
 - Provides information on the percent of patients discharged from the IPF who visit an emergency department within 30 days of their discharge, without a subsequent readmission.
- Reporting period begins with data from the calendar year (CY)
 2025 performance period/FY 2027 payment determination year.
- This is a claims-based measure, and there is no additional data collection burden or submission by IPFs.

Proposal to Modify Data Submission Requirements

- CMS proposed to require IPFs to submit patient-level quality data on a quarterly basis beginning with the CY 2025 performance period/FY 2027 payment determination.
- Based on comments received, CMS is not finalizing the proposal to modify data submission requirements to require quarterly data submission at this time.
- IPFs will continue reporting patient-level data on an annual basis

Request for Information: IPF-PAI

- CMS requested information from the public to inform the selection of Standardized Patient Assessment Data Elements to be collected on the IPF-PAI and implementation process.
- CMS will take the comments received into consideration in the development of the IPF-PAI.
