**Background and Anticipated Plan for IPF-PAI Development and Testing (IPF-PAI Alpha Test)** 

#### **CAA of 2023**

The CAA of 2023 amended Section 1886(s) of the Social Security Act to require the Secretary of Health and Human Services to implement a standardized IPF-PAI that includes data elements related to the following:

- Functional status
- Cognitive function and mental status
- Special services, treatments, and interventions
- Medical conditions and comorbidities
- Impairments
- Other categories deemed appropriate

## **CMS Commitment to Quality**

- Quality Mission: To achieve optimal health and well-being for all individuals
- Quality Vision: CMS is a trusted partner in shaping a resilient, high-value American health care system that delivers high-quality, safe, and equitable care for all.

## **IPF-PAI** Development

- CMS has contracted with RTI International, Abt Global, and their partners to develop the IPF-PAI.
- The IPF-PAI is intended to:
  - Meet the requirements of the CAA of 2023.
  - Be a part of an IPF's existing assessments and processes.
- Input from and collaboration with IPFs is essential.

#### **Anticipated Plan for IPF-PAI**

CMS's anticipated plan for development of the IPF-PAI includes multiple activities:

- Gathering information
- Engaging technical experts, clinical experts, interested parties, IPF staff, and IPF providers
- Engaging individuals who have received inpatient psychiatric care, their families, and/or caregivers
- Testing with IPFs to evaluate candidate data elements and the draft IPF-PAI

## **IPF-PAI** Testing

- Alpha Test
  - Cognitive interviews
  - Survey
  - Focus groups
- Field (Beta) Test
  - Evaluate draft IPF-PAI in the field

## IPF-PAI Alpha Test (1 of 3)

Recruit IPF staff to volunteer for one, two, or all three of these activities:

- Cognitive interviews will evaluate clarity and completeness of candidate data elements and associated guidance.
- Focus groups will provide input on the following:
  - Current admission and discharge workflows, assessments, and team roles and responsibilities
  - Perceived anticipated facilitators or barriers to implementation
  - Candidate data elements
- Surveys of the staff who complete admission and discharge assessments will provide input about candidate data elements' relevance to IPF and clinical usefulness.

## IPF-PAI Alpha Test (2 of 3)

- Virtual training modules will last no more than three hours total.
- Abt project team will coordinate with IPF staff participants to schedule interviews, and/or focus groups, and/or send survey link.
  - We will send participants Teams or WebEx meeting invitations.
- Each IPF staff participant will receive a \$50 gift card for each activity they complete (up to three \$50 gift cards, or \$150 total).
