The purpose of this presentation is to provide an overview of CMS's development of a standardized PAI, plan to develop and test the IPF-PAI, and the current IPF-PAI testing phase, also known as IPF-PAI Alpha Test.

**Kaleigh Emerson:** Thank you, Lisa. Hello, everyone. My name is Kaleigh Emerson, and I am the Inpatient Psychiatric Facility Quality Reporting Program lead at the Centers for Medicare & Medicaid Services. I want to welcome you to today's webinar.

We thank you for joining this presentation about the Inpatient Psychiatric Facility-Patient Assessment Instrument, also called the IPF-PAI. Insight from those working in IPFs is essential to the development of a patient assessment instrument that is meaningful and appropriate for the IPF setting and the population of individuals that are treated in IPF. We greatly value IPF participation in the development and testing of the IPF-PAI, and we appreciate your time and commitment to helping advance the quality of inpatient psychiatric care. So, thank you again, and I will turn it over to Jennifer Riggs.

**Jennifer Riggs:**

Hello, and welcome everyone. My name is Jennifer Riggs, and I will be presenting information about the background of the IPF-PAI and our anticipated plan for development and testing. Then, I will provide some details about our current phase of testing, the IPF-PAI Alpha Test.

The Consolidated Appropriations Act of 2023 amended Section 1886 (s) of the Social Security Act to require the Secretary of Health and Human Services to implement a standardized patient assessment for inpatient psychiatric facilities participating in the IPF Quality Reporting Program. The CAA of 2023 has its roots in the IMPACT Act of 2014. That is the Improving Medicare Post-Acute Care Transformation Act, which requires submission of standardized patient assessment data by post-acute care settings. These are long-term acute hospitals, inpatient rehabilitation facilities, skilled nursing facilities, and home health agencies, using their existing standardized patient assessment instruments. The IPF standardized patient assessment data identified in the CAA of 2023 are data with respect to the following categories: functional status, such as mobility and self-care and admission to a psychiatric hospital or unit, and before discharge from that psychiatric hospital or unit; cognitive function, such as the ability to express ideas and to understand, and mental status, such as depression and dementia; special services, treatments, and interventions for psychiatric conditions; medical conditions and comorbidities, such as diabetes, congestive failure, and pressure ulcers; impairments, such as incontinence or an impaired ability to hear, see, or swallow; and other categories as determined by the Secretary.

As described in CMS's quality strategy, CMS's quality mission is to achieve optimal health and well-being for all individuals. The quality vision is that CMS is a trusted partner in shaping a resilient, high-value American healthcare system that delivers high-quality, safe, and equitable care for all.

CMS has contracted with RTI International, Abt Global, and their partners to develop and test a draft standardized patient assessment instrument for IPFs, the IPF-PAI. The IPF-PAI is intended to meet the requirements of the CAA of 2023, and it is intended to be integrated into IPF existing assessments and workflows. To develop a meaningful and appropriate patient assessment instrument for IPF, collaboration with IPF staff and providers is essential.

CMS's anticipated plan for the development of the IPF-PAI includes multiple activities such as information gathering from the literature, clinical practice guidelines, and many other sources; engagement with experts and interested parties, including IPF staff and providers, and also including individuals who have received inpatient psychiatric care and their families and or their caregivers; and testing with IPF sites and staff to evaluate candidate data elements to include in the Standardized Assessment Instrument; and testing to evaluate the draft IPF-PAI.

The phases of testing that are planned in the development of the IPF-PAI include an Alpha Test, which will consist of cognitive interviews, a survey, and focus groups. We will discuss the Alpha Test in more detail in the next few slides. The Alpha Test will be followed by a field test, also called a Beta Test, to evaluate the performance of the draft IPF-PAI in the field.

The anticipated timeline for IPF-PAI development and testing includes ongoing and iterative information gathering and engagement with experts and interested parties. The Alpha Test is currently underway and is expected to complete before the end of January 2025. We anticipate that the field test of the draft IPF-PAI will occur in the late spring and summer of 2025. We expect testing and analysis to be completed in the fall of 2025.

Following completion of testing and analysis, CMS may propose the IPF-PAI in future rulemaking.

CMS and Abt are recruiting IPF staff for cognitive interviews, a survey, and focus groups. IPF staff can volunteer for one, two, or all three activities. Participation is completely voluntary. There is no penalty or adverse consequence for anyone who chooses not to participate. Cognitive interviews allow us to evaluate the clarity and completeness of candidate data elements or assessment questions and their associated instructions or guidance. Focus groups will provide input about current IPF admission and discharge workflows and processes, current assessments, and IPF team roles and responsibilities. We will be asking for input about perceived anticipated facilitators or barriers to implementation of the IPF-PAI. We will also be asking for additional input about the candidate data elements. In the survey, we will ask IPF staff who complete admission and discharge assessments to provide input about the candidate data elements' relevance to the IPF setting and patient populations, and clinical usefulness.

For IPF staff who volunteer to participate, the process starts with virtual training modules that explain the Alpha Test and describe the candidate data elements and their associated instructions. The training will require no more than three hours to complete. After completing the training, the Abt project team members will coordinate with IPF staff participants to find the best day and time to schedule the interview and/or focus group or to send the survey link. We plan to use Microsoft Teams to conduct interviews and focus groups, and we will email the invitation and link to each participant individually. We expect interviews to be completed in December. Focus groups will start in December and be completed in January, and we expect to send the survey link in late December or early January to any IPF staff who volunteered to complete the survey. We are pleased that we can offer participants a token of our appreciation for your participation, \$50 gift card to each participant for each activity completed.
