IPFQR Program Resource Guides

- The *IPFQR Program: Accessing and Using Your Provider Participation Report (PPR)* guide describes how IPFs can access, download, and interpret the IPF PPR.
- The *IPFQR Program: Accessing Data in Your Facility, State, and National (FSN) Report* summarizes how IPFs can access, download, and interpret the IPF FSN report.
- The fiscal year (FY) 2025 and 2026 **IPFQR Program Guides** describe details about the IPFQR Program including participation requirements, general information about measures, the data submission process, and public reporting for FY 2025 and FY 2026, respectively.
- The **CMS IPFQR Program Measures and Non-Measure Data Needed to Meet FY 2025 and 2026 APU Requirements** describes the IPFQR Program's annual payment update (APU) data requirements for FY 2025 and FY 2026, respectively.
- The *IPFQR Program Quick Reference Guide: Fiscal Year (FY) 2026 Data Accuracy and Completeness Acknowledgement (DACA)* summarizes the IPFQR Program's FY 2026 DACA requirement.

IPFQR Program Paper Tools

- The paper tools provide an *optional*, informal abstraction mechanism to assist inpatient psychiatric facilities in the collection of data for the IPFQR Program. This pertains to measure data to be reported in the summers of 2024 and 2025, impacting the FY 2025 and 2026 payment determinations, respectively.
- CMS posted the following revised paper tools for information to be submitted in the summer of 2024:
 - Influenza Immunization (IMM)-2 measure data
 - Tobacco Use (TOB-3/-3a) measure data
 - Non-measure data
- CMS posted the following paper tools for information to be submitted in the summer of 2025:
 - Hospital-Based Inpatient Psychiatric Services (HBIPS)-2, -3 measure data
 - Screening for Metabolic Disorders measure data
 - Substance Use (SUB-2/-2a, -3/-3a) measure data

- Tobacco Use (TOB-3/-3a) measure data
- Transition Record with Specified Elements Received by Discharged Patients (TR-1) measure data
- Non-measure data
