Subject: **CMS Releases Fiscal Year 2025 Hospital Value-Based Purchasing Program Medicare Spending per Beneficiary Measure Hospital-Specific Reports**

The Medicare Spending per Beneficiary (MSPB) Hospital-Specific Reports (HSRs) for the fiscal year (FY) 2025 Hospital Value-Based Purchasing (VBP) Program were delivered on **May 30, 2024**.

The MSPB measure assesses Medicare Part A and Part B payments for services provided to a Medicare beneficiary during a spending-per-beneficiary episode that spans from three days prior to an inpatient hospital admission through 30 days after discharge. The measure includes price-standardized and risk-adjusted payments. Price standardization removes sources of variation that are due to geographic payment differences, such as wage indexes, geographic practice cost differences, indirect medical education, and disproportionate share hospital payments. Risk adjustment accounts for variation due to patient health status.

Accessing the HSR

- Follow the steps below to access your HSR in the HQR System:
 - Log into the HQR System using your Health Care Quality Information Systems Access Role and Profile (HARP) Account. Select Log In.
 - Choose the authentication method. Select Next.
 - Enter your code. Select Next.
 - Go to the navigation menu on the left side of your screen.
 - Select Program Reporting. Select Claims-Based Measures.
 - Select the Release Year (2024), Program (MSPB), and the report (HVBP-MSPB). Select Export.

Review and Correction Period Requests

CMS is providing HSRs for the Hospital VBP Program MSPB measure review and correction period. The period ends at 11:59 p.m. Pacific Time (PT) on July 1, 2024. This review and corrections process does not allow hospitals to submit additional corrections related to the underlying claims data or add new claims to the data extract used to calculate the results. The HSRs are designed to provide hospitals the opportunity to review measure results, check episode data used in the calculation of the claims-based measures and replicate their results. Discrepancies or concerns regarding the claims or results included in the HSRs must be reported during the review and correction period to be considered by CMS. Any requests for the

adjustment of claims, measure results, measure scores, or notation of those measure results **will not be considered if the request is submitted after July 1, 2024**. Review and correction period requests can be submitted through the Questions and Answers Tool on QualityNet. When submitting the request, select **Inpatient Claims-Based Measures** from the Program drop-down menu. Then, select **Review & Correction Request** from the MSPB topic drop-down menu. In the subject line, type **FY 2025 Hospital VBP Program MSPB HSR Review and Correction Request**. Please describe your question in the text box and include your hospital's CMS Certification Number (CCN) and your question or request for correction.

Note: Do not email HSR files or their contents. HSRs contain discharge-level data protected by the Health Insurance Portability and Accountability Act of 1996 (HIPAA). Any disclosure of protected health information should only be in accordance with, and to the extent permitted by, the HIPAA Privacy and Security Rules and other applicable law. Use the ID number found within the HSR when referring to the contents of that report.
