Hospitals participating in the Prospective Payment System-exempt Cancer Hospital Quality Reporting (PCHQR) Program have a deadline of 11:59 p.m. Pacific Time (PT) on **Thursday**, **August 15**, **2024**, to submit data for the healthcare-associated infection (HAI) and COVID-19 Vaccination Coverage Among Healthcare Personnel (HCP) measures.

Please enter your data into the National Healthcare Safety Network (NHSN) for the **HAI and COVID-19 HCP measures** listed below. The data will be submitted via the Centers for Disease Control and Prevention to the Centers for Medicare & Medicaid Services (CMS).

**Important Note:** In NHSN, a week belongs to the month in which the week <u>ends</u>. NHSN will not send a hospital's Quarter (Q)1 2024 COVID-19 HCP measure data to CMS unless there is at least one week of data that ends in January, one week of data that ends in February, and one week of data that ends in March.
