**Subject:** April 2025 Public Reporting Preview Data Available

Today through March 14, 2025, on the CMS Hospital Quality Reporting (HQR) page (<https://hqr.cms.gov/hqrng/login>), you can preview your hospital or inpatient psychiatric facility's quality data that will publicly appear in the April 2025 release on the [Compare tool on Medicare.gov and the Provider Data Catalog available at data.cms.gov/provider-data/](#). Medicare beneficiaries and the public can use these tools to view quality measure data for participating hospitals and facilities.

The Centers for Medicare and Medicaid Services (CMS) has paused the public display of Hospital Promoting Interoperability Electronic Health Record (EHR) icon on the Compare tool on Medicare.gov. The Promoting Interoperability data is not currently available on the Care Compare tool on Medicare.gov. The Provider Data Catalog website has limited data reported for Promoting Interoperability within the new Promoting Interoperability dataset, such as the Certified Electronic Health Record Technology (CEHRT) ID. While Promoting Interoperability data was included during the January 2025 preview period, the Promoting Interoperability Facility Score will not be publicly reported at this time. CMS will continue to communicate system updates.

### **When can I see my hospital's preview data?**

From the HQR page, you have 30 days to preview the data that will appear on the April 2025 release. We encourage you to look at your information early in this preview period to conduct a thorough review.
